- 6. Cancellations: If for any reason the guest cancels this agreement more than 60 days from arrival date, the reservation deposit will not be refunded unless owner is able to rerent the property under the same terms and conditions of this agreement for the full term reserved. There are no cancellations permitted within 60 days of arrival date. All amount paid will be forfeited. Early departure does not warrant a partial refund. While we attempt to make any necessary repairs quickly and efficiently, there is no refund for appliance failure, utility failure, or other circumstances beyond our control.

- 7. **Weather**: Bad weather refunds will be made for mandatory hurricane evacuation only. Rent will be prorated for a partial refund.
- 8. **Clean-up on departure:** Before vacating, please clean the premises thoroughly, which includes the following:
